TULSA AREA USBC FALL SENIOR CLASSIC TOURNAMENT

- 1. Entry is open to all USBC members, 50 years of age and over as of midnight September 20, 2023, who are members of the Tulsa Area USBC Association. Tournament will be certified by USBC. Bowlers need not belong to a senior league to be eligible for entry in this tournament.
- 2. Bowlers will be in one of four divisions: Women Seniors 50-65, Women Super Seniors 66 & Up, Men Senior 50-65 or Men Super Seniors 66 & Up.
- 3. Tournament will consist of Singles Event only, with four divisions MEN and WOMEN, Senior and Super Senior. Handicap will be 85% from 220.
- 4. Participants will bowl three games using two lanes.
- 5. ENTERING AVERAGE RULES:
- A. Entrants will use their highest 2022/2023 Tulsa Area USBC Average of at least 21 games or more from winter leagues as listed on Bowl.com.
- B. If Rule A cannot be applied, the entrant shall use his/her highest 2023 summer league average of 21 games or more in one league.
- C. If Rule A or B cannot be applied, the entrant shall use current year's average of 21 games or more in league as of September 20, 2023. Verification must be provided. 10 pin rule will apply
- D. All others bowl scratch.
- E. This tournament will not require the use of summer averages.
- F. It shall be bowler's responsibility to verify the accuracy of his/her average. Failure to use the correct average shall disqualify the score if submitted average is lower than correct average, thereby resulting in more handicap. Prize winnings will be based on the submitted average if it is higher than the correct average.

 Corrections in averages can be made up to the completion of the first game or within 48 hours after completion of the series, if the Tournament Manager, prior to completion of the first game, has given written consent to the bowler authorizing such extension of time to correct average.
- G. All members of PBA, who have participated in two(2) PBA events during the previous 24 months must bowl scratch.
- 6. USBC Rule 319-a-2, 319-c and 319-d will not be waived.
- 7. Prize fee will be returned to participants 100%. Prize Ratio at least 1 place for each 5 entries.
- 8. In the event of first place ties, co-champions will be declared and the prize money will be combined and divided equally.
- 9. It shall be the bowler's responsibility to complete the entry form with the squad time, and indicate entering average rule to be applied as above RULES 5 A, B, C, D OR G.
- 10. The Tournament Committee shall have the authority to decide any other matters pertaining to the operation of the tournament not covered by the rules.
- 11. Trophies and Prize Fund will be presented within 30 days of completion of the Tournament.

Fee for all squads must be paid by entry closing date: September 20, 2023
